## FISHING VESSEL - LIFE SAVING EQUIPMENT REQUIREMENTS

### FISHING VESSEL SIZE:

# More than 6m (19'8") but not more than 9m (29'6")(Hull length) These Regulations apply in respect of fishing vessels that are Canadian vessels and that are not more than 24.4 m in length and not more than 150 gross tonnage.

Additional Equipment	<ul> <li>A Bailer OR Manual Bilge Pump, Fitted with or accompanied by a sufficient length of piping or hose to enable water to be pumped from the bilge space; AND</li> <li>A Magnetic Compass and capable of being illuminated; AND</li> <li>A means of determining the depth of water under the vessel; AND</li> <li>A Sound Signalling Device; AND</li> <li>An anchor of sufficient weight, along with anchoring equipment, that can be deployed and retrieved effectively; AND</li> <li>Bucket-capacity of 10 L or more and be fitted with a lanyard of sufficient length to reach the water from it's stored location</li> </ul>		
First Aid Kit	<ul> <li>Marine emergency first aid kit as per Section 3.24 of the FVSR; OR</li> <li>First aid kit that meets Maritime Occupational Health and Safety Regulations; OR</li> <li>First aid kit that meets provincial workplace safety regulations with face shield and two pairs of gloves.</li> </ul>		

requirements.

1. A fishing vessel is not required to carry on board pyrotechnic distress signals if the vessel is equipped with a two-way radio system and is operated exclusively in the confines of a manned aquaculture facility OR within 500 m from shore OR operates on a river, canal or lake where it is never more than one nautical mile from shore.

### 3. EPIRB or other equipment

(3) A vessel that is 12 m or less in length and engaged on an inland voyage in the waters of the Great Lakes, their connecting and tributary waters or the waters of the St. Lawrence River, or on a near coastal voyage, Class 2, must be equipped with (a) a float-free EPIRB;

(b) a manually activated EPIRB; (c) a PLB; or

(d) in the case of a vessel that is less than 8 m in length and that operates exclusively in sea area A1, a waterproof portable VHF handheld radio capable of DSC. Manual EPIRB or other equipment — location

(4) A manually activated EPIRB, a PLB or a portable VHF handheld radio capable of DSC must be worn by the person in charge of the navigational watch or, if that is not practicable, stowed so that it is readily accessible for immediate use in the event of abandonment of the vessel.
