

# FISHING VESSEL - LIFE SAVING EQUIPMENT REQUIREMENTS

## FISHING VESSEL SIZE:

### More than 9m (29'6") but not more than 12m (39'4") (Hull length)

<b>Lifejackets and Personal Life Saving Appliances</b> (For each person on board)  *PFDs for a Fishing Vessel need to be High Visibility, fitted with retro-reflective tape and have a whistle. <b>Life Saving Appliances</b>	<ul style="list-style-type: none"> <li>• 1 or more Life Rafts or Recovery Boats for 100% of persons on board; <b>OR</b></li> <li>• The following equipment: 1 EPIRB or 2-way Radio; <b>AND</b> An Immersion Suit or Anti-Exposure Work Suit of appropriate size for each person on board; <b>OR</b></li> <li>Life saving appliances or procedures for protection from the effects of hypothermia or cold shock</li> </ul>	<ul style="list-style-type: none"> <li>• The following equipment: 1 or more Life Rafts or a combination of Life Rafts and Recovery Boats for 100% of persons on board; <b>AND</b> 1 Float-free or manually activated EPIRB or a 406 MHz Personal Locator Beacon (PLB); * <b>OR</b></li> <li>• The following equipment: 1 Float-free or manually activated EPIRB; <b>AND</b> An Immersion Suit or Anti-Exposure Work Suit of appropriate size for each person on board</li> </ul>	<ul style="list-style-type: none"> <li>• 1 or more SOLAS Life Raft or reduced capacity Life Rafts for 100% of persons on board; <b>AND</b></li> <li>• 1 Float-free EPIRB; <b>AND</b></li> <li>• An Immersion Suit of appropriate size for each person on board</li> </ul>
<b>Person Overboard Retrieval Devices</b>	<ul style="list-style-type: none"> <li>• 1 Buoyant heaving line of not less than 15 m in length; <b>AND</b></li> <li>• 1 approved lifebuoy with not less than 15 m of buoyant line attached; <b>AND</b></li> <li>• 1 Reboarding device; <b>AND</b></li> <li>• 1 Person overboard retrieval apparatus* <b>OR</b> Vessel carries a recovery boat (that meets Part B and Part C of TP 14475, or TP1332). *not required if only one person on board</li> </ul>		
<b>Visual Signals</b> <sup>1</sup>	<ul style="list-style-type: none"> <li>• 1 Watertight flashlight; <b>AND</b></li> <li>• 1 Signalling mirror; <b>AND</b></li> <li>• 6 Pyrotechnic distress signals of which not more than three are smoke signals</li> </ul>	<ul style="list-style-type: none"> <li>• 1 Watertight flashlight; <b>AND</b></li> <li>• 1 Signalling mirror; <b>AND</b></li> <li>• 6 Pyrotechnic distress signals of which at least two must be rocket parachute flares and not more than three are buoyant smoke signals</li> </ul>	
<b>Fire Fighting Equipment</b> <sup>2</sup>	<ul style="list-style-type: none"> <li>• 1 Portable fire extinguisher of type 2A:10B:C; <b>AND</b></li> <li>• 1 Portable fire extinguisher of type 2A:10B:C, at each access to a space with fuel-burning appliances; <b>AND</b></li> <li>• 1 Portable fire extinguisher of type 10B:C at the entrance to the engine space; <b>AND</b></li> <li>• 1 Fire axe; <b>AND</b></li> <li>• 1 Bucket (for firefighting) 10 L or more and be fitted with a lanyard reach the water from the location in which it is stored</li> </ul>		
<b>Additional Equipment</b>	<ul style="list-style-type: none"> <li>• A Manual Bilge Pump, Fitted with or accompanied by a sufficient length of piping or hose to enable water to be pumped from the bilge space; <b>AND</b></li> <li>• A Magnetic Compass and capable of being illuminated; <b>AND</b></li> <li>• A means of determining the depth of water under the vessel; <b>AND</b></li> <li>• A Sound Signalling Device; <b>AND</b></li> <li>• An anchor of sufficient weight, along with anchoring equipment, that can be deployed and retrieved effectively</li> </ul>		
<b>First Aid Kit</b>	<ul style="list-style-type: none"> <li>• Marine emergency first aid kit as per Section 3.24 of the FVSR; <b>OR</b></li> <li>• First aid kit that meets Maritime Occupational Health and Safety Regulations; <b>OR</b></li> <li>• First aid kit that meets provincial workplace safety regulations with face shield and two pairs of gloves.</li> </ul>		

1. A fishing vessel is not required to carry on board pyrotechnic distress signals if the vessel is equipped with a two-way radio system and is operated exclusively in the confines of a manned aquaculture facility OR within 500 m from shore OR operates on a river, canal or lake where it is never more than one nautical mile from shore.

3. EPIRB or other equipment

(3) A vessel that is 12 m or less in length and engaged on an inland voyage in the waters of the Great Lakes, their connecting and tributary waters or the waters of the St. Lawrence River, or on a near coastal voyage, Class 2, must be equipped with

(a) a float-free EPIRB;

(b) a manually activated EPIRB; (c) a PLB; or

(d) in the case of a vessel that is less than 8 m in length and that operates exclusively in sea area A1, a waterproof portable VHF handheld radio capable of DSC.

Manual EPIRB or other equipment — location

(4) A manually activated EPIRB, a PLB or a portable VHF handheld radio capable of DSC must be worn by the person in charge of the navigational watch or, if that is not practicable, stowed so that it is readily accessible for immediate use in the event of abandonment of the vessel.

2. See the equivalent classification of portable fire extinguishers that meet these carriage requirements.
