A fishing vessel is not required to carry on board pyrotechnic distress signals if the vessel is equipped with a two-way radio system and is operated exclusively in the confines of a manned aquaculture facility OR within 500 m from shore OR operates on a river, canal or lake where it is never more than one nautical mile from shore.

This list is being provided as a Quick Reference Guide based on information contained in the Fishing Vessel Safety Regulations (in force July 13, 2017) and the Navigation Safety Regulations 2020 (in force October 28, 2020). This list is not intended to be all inclusive or referencing all Sections of these Regulations. Owners and Operators of fishing vessels should consult with their local Transport Canada Marine Safety and Security office or the Transport Canada website for further information.
